

Winterfest and South,Life Dining (‘Event’ and ‘Competition’) TERMS AND CONDITIONS

These Event Terms (Terms) govern your entrance for, and attendance at the Winterfest (Event) and South,Life Dining (Competition) held by South.Point Shopping Centre. It is your responsibility to review these terms prior to your admission into the event zone or competition. By entering the event zone or competition you agree to be bound by these Terms.

Throughout these Terms, the terms “South Point”, “we”, “us” and “our” refer to South.Point Shopping Centre and its associated entities, and “you” refers to the individual or business attending the event.

1. Winterfest Event

- 1.1 The event does not require bookings and will be open on the 5th, 6th, 7th, 8th, 12th, 13th, 14th and 15th of August from 5.00pm – 8.00pm.
- 1.2 You must check in using the CBR App before entry into the zone
- 1.3 Each person who enters the zone, who is over the age of 18 is entitled to one free glass of mulled wine.
- 1.4 FREE glass of mulled wine is only valid for one glass per person per day.
- 1.5 There are only 100 glasses of wine redeemable each day, once the 100 glasses have been redeemed the mulled wine bar will be closed until 5pm the following day of the event
- 1.6 Individuals are permitted to be within the Winterfest event zone for a period of 90 minutes, at which staff may ask you to leave the event zone
- 1.7 The free glass of wine is at our discretion and we may refuse service for any reason where we see fit.
- 1.8 Responsible service of alcohol guidelines will be followed and anyone who appears to be intoxicated may be refused service and will be asked to leave the event

2. South,Life Dining Competition

- 2.1 To enter into the draw to win a SouthLife Dining Voucher you must supply your information on the supplied paper and submit it into the barrel located within the Winterfest zone on the above mentioned open times.
 - 2.1.1 Winners will be drawn on the 16th of August and will be notified via email.
 - 2.1.2 Gift cards will be available for pick up from the 30th of August from the customer service desk at South.Point Shopping Centre
 - 2.1.3 Entries are limited with one entry per day permitted
 - 2.1.4 Winners are capped at 2 x dining vouchers. If an entrant is drawn for a third time there will be a re-draw.
 - 2.1.5 If winners have not collected their prizes from the customer service desk by the 30th of September the prize will be forfeited.
- 2.2 To enter into the Ultimate Dining Experience you must take an image while in the Winterfest zone at the above mentioned opening times and #southlife on either Facebook or Instagram. Profiles or posts must be made public so we can see the entry
 - 2.2.1 Entrants into this competition are not limited and each image posted counts as an extra entry.
 - 2.2.2 South.Point reserves the right to use the images from this competition for promotional purposes to advertise this event or other events at South.Point Shopping Centre
 - 2.2.3 Winners will be drawn on the 16th of August and will be notified via their social media account used to post the image

- 2.2.4 The prize will be able to be collected form the customer service desk at South.Point Shopping centre from the 30th of August, or earlier where advised by a South.Point Marketing staff member.
- 2.2.5 If the winner has not redeemed their prize by writing back to South.Point by the 30th of August the prize will be forfeited.

3. Event Conduct

- 3.1 You are expected to behave in an appropriate manner at all Events at South.Point Shopping Centre. We reserve the right to refuse entry or require you to leave if your behaviour is deemed unacceptable
- 3.2 South.Point films and photographs every event. You consent to being filmed of photographed by South.Point (or its representatives) and to South.Point using your name, likeness, image and/or voice in such photographs or films for the purpose of promotion our events, services and products. No remuneration if payable for such use.

4. Limitation of Liability

- 4.1 To the extent permitted by law, we exclude all conditions and warranting relating to your purchase of tickets for and attendance at Events.
- 4.2 Where our liability cannot be excluded, such as in relation to Consumer Guarantees under the Australia Consumer law or other prescribed terms under legislation, our liability for breach is limited to the face value of the ticket purchase by you.
- 4.3 We will be excused from performance under these Terms and in relation to Events to the extent such performance is affected by a Force Majeure Event.

5. Release of Liability

- 5.1 By entering the event you agree to waive, release, and discharge South.Point Shopping Centre and its representatives (meaning an employee, volunteer, agent, office, contractor or other authorised representations), from any and all liability for loss, claims, demand, injury or expense, that you suffer as a result of participation in the event.

6. Miscellaneous

- 6.1 In these Terms, a “Force Majeure Event” means any of the following (whether or not foreseeable or anticipated): acts of God, terrorism, war, civil unrest, strike or labour dispute, lack of transportation, breakdown, labour or material shortage, blockage or embargo, supplier failure, epidemic or pandemic, government restriction or recommendation, legal requirement, extreme weather, earthquake ,drought, fire, flood, explosions, natural disaster, and/.or any other event, cause or circumstance that is beyond our reasonable control.
- 6.2 These terms constitute the entire agreement between South.Point and you in relation to the Event
